#### **Old Business**

## **Individual Reports**

Pastors Report: July report is attached.

Several things highlighted: Communications team includes Pastor Karen, Donette, Kim Lomas and it should include the Ad Council Chair and someone from tech team. No "first" meeting yet; Karen/Donette are involving the Care Team and others in getting information out to everyone in the meantime.

Michelle Smith has stepped down as the Ad Council Chair. Barb Truitt-Peterson has stepped down as Lay Leader but will continue with SPRC and on the nomination team. Phyllis has stepped down as Historian and we also have Steve Duff as Temporary Trustee Chair that has gone much longer than Steve had plannedl.

Pastor Karen talked over the possibility of collaboration with other churches (Connect Church in Farmington is very interested; Castle Rock UM also a possibility; prayers requested for God's leading; details are in the report.

**Three points**: Pray about collaborating, pray for new leaders and supporting and encouraging people to listen to God's call and to step up and lead as we work hard together to lean into the mission of the church.

**Pastor** We will have a Charge Conference to elect new leaders, and the Council can do that in the Fall to bring before the church. We might need to make special arrangements to help all who who want to participate in the Charge Conference to do so.

Mary F. Will we have church service outside? Yes on August 2nd. We will have a shorter service at 9:30 online and then encourage people to come to the front of the church at 10:00, they can bring chairs and sit in front of their cars or stay in their car. They can drive around to the back of the church for communion. Tim and Allison will be collecting donations for the Farmington food shelf. We need others to serve as ushers and Communion servers

Cory; We have everything needed to make this work. The AM transmitter will still be going for those who stay in cars.

\*Pastor Karen will work from home August 3-9 in order to keep safe distance while her sister is visiting from Germany. Other volunteer leaders will be in charge of Loaves and Fishes Aug 5.

**Trustees** -- Parking lot crack was sealed; Working on Fire inspection items, pushed the date back to August 18th; Finishing up painting inside the building.
